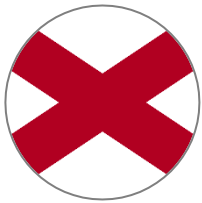

How Employers Use E-Response

NOTICE: SIDES E-Response is managed by the state from whom the request is received. If you want to sign up for SIDES E-Response, are having issues logging in to E-Response, or have questions about how E-Response works in your state, please scroll to the appropriate state on this document. There you will find the information provided by the state regarding their E-Response procedures.



Alabama

To connect to E-Response you will need your FEIN, UC Employer Account Number and Authorization/Access Code to log in. The Authorization/Access Code is listed on the Ben 241 form that you received in the mail, or contained in an email notification you may have received. Alaska

To enroll in email notification and responses for separations and earnings verification, you must send an email to dol.sides@alaska.gov. You will need to provide a contact name and phone number, FEIN, and State Employer Identification Number (SEIN) to enroll. Arizona

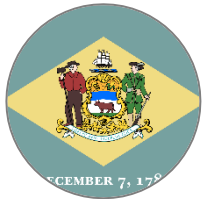

District of Columbia

To register, you need your six-digit State Employment Identification Number (SEIN) and your nine-digit FEIN. Click on the **New Employer Registration** link to begin the registration process.

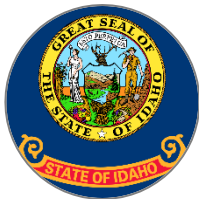
Georgia

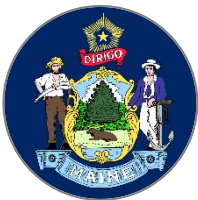

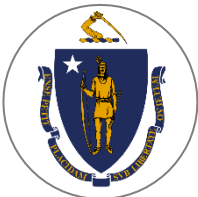

Michigan

To submit an E-Response reply, employers will need FEIN, Michigan UIA Tax Account Number, and PIN. To generate an email PIN request, Michigan has implemented SIDES E-Response. Employers that do not currently have a SIDES Pin can logon their MIWAM account and create their own pin. It is located under the "I want To" section of MiWAM. Click on the Link labeled Sign Up for SIDES E-Response and create a four-digit pin. 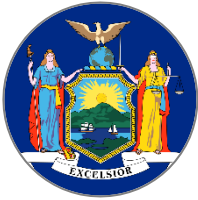
New Jersey

To sign up and receive your notices by e-mail with the ability to respond through SIDES E-Response, go to www.dws.state.nm.us. You will need your New Mexico Department of Workforce Solutions Employer Account Number and your password to log into the Unemployment Insurance Tax & Claims System. Once you are logged in, on your employer home page, select Account Maintenance > Address Information > Correspondence Preferences to confirm your current correspondence delivery method is e-mail. On your employer home page, select 'SIDES E-Response Alternative' under the SIDES Information section and follow the prompts. Need help? You can email uitax.support@state.nm.us or call 1-877-664-6984, and select Option 3 to speak to a representative.



New York

To sign up for an Unemployment Insurance Online Services account or to upgrade to SIDES E-Response, go to <http://labor.ny.gov/ui/Authentication/index.shtm>, log into to your employer account, and follow the prompts. You may also call 1 (888) 899-8810 and choose Option 2, then Option 4. A representative will review your account and sign you up for E-Response.

The contact email address will be used to receive notifications that a separation information request against the employer account is available in the E-Response system. After processing the registration request, the support unit will contact you with the applicable information needed to utilize the E-Response system.



Oklahoma

To log on: The Federal Employer Identification Number (FEIN) is entered without dashes (Example: 000000000). The State Employer Identification Number (SEIN) is entered using 7 digits, a dash, and the additional digit (Example: 0000000-0).



Pennsylvania

Employers with questions may email PASIDES@pa.gov or call **717-783-0612**, or find more information at [State Information Data Exchange System \(SIDES\) \(pa.gov\)](http://www.pa.gov). When logging in, no hyphens are needed; instead, employers should use 9 digits in the Federal Employer Identification Number (FEIN) field, e.g., 231234567, and 7 digits in the State Employer Identification Number (SEIN) field, e.g., 0012345. Employers able to log into the [UC Benefits system](#) can also use single sign on to access their Separation Information requests by either clicking "Claimant Separation Form" from the dashboard, or "More Unemployment Services", then "SIDES E-Response", and then "Separation Information (SI)".

Employers can register for SIDES E-Response by logging into eServices at esd.wa.gov and selecting “SIDES E-Response” on the bottom-left of the page.

E-Response will send employers notifications when a former employee applies for unemployment benefits. These notifications will ask employers to log in to uisides.org and to provide the following information:

- Federal Employer Identification Number (FEIN) without the hyphen.
- ESD number.
- SIDES personal identification number (PIN).

If employers don't know this information, they can log in to eServices at esd.wa.gov and select "SIDES E-Response" on the bottom-left of the page.
